OPERATOR: You've only just called us so it will take a minute for them to get there.

CALLER: Yes, yes.

OPERATOR: Can I let you go?

OPERATOR: Hello?

CALLER: (Inaudible) Grab it and leave! Just leave! What kind of person is she?

OPERATOR: Hello?

CALLER: What? Hello?

OPERATOR: Can I let you go. You are outside, yeah?

CALLER: Yeah, I'm outside.


